We have a few parents that collect other children belonging to another family **regularly** from school. This is agreed with the class teacher at the start of the year.



Parents Consultations


Tuesday 8th February and Wednesday 9th February

When you attend your meeting, please follow the guidance below:


- Arrive only 5 minutes before your meeting time
